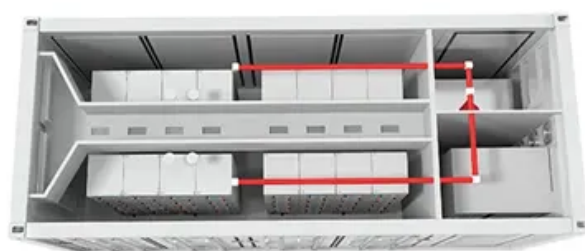


Belgium lithium batteries are prohibited from solar container outdoor power

Which batteries do I need to declare?

All portable, industrial and automotive batteries put on the Belgian market must be declared to Bebat. This applies to both batteries sold separately (replacement market) and built-in and supplied batteries.
