### Tracking US solar imports-and the impact of tariffs

The tariff started at 30% in 2018, stepping down 5% each year (to 15% by year 4). Certain developing countries with minimal export volume were exempt, but the major suppliers were subject to it.

### April 2025 Tariffs , Solar Equipment , Industry Impact

In summary, as of April 2025 we see solar panel prices up by 20-40% (depending on origin), inverters up ~10-30%, and battery costs up significantly (~30% or more) compared to pre-tariff levels.
