

Myanmar solar module export tariffs



Overview

The Ministry of Planning and Finance grants customs tariff exemption, in the exercise of the power conferred by Section 7 (A) of the Tariff Law, according to its notification dated 20 April. To have energy sufficiency, solar and related components are exempt from customs tariffs. The exemption announcement comes as the Yangon Electricity Supply Enterprise and Naypyitaw Electricity . Myanmar's tariff schedule is based upon the ASEAN Trade in Goods Agreement (ATIGA) tariff schedule, which in turn is based on the Harmonized System Nomenclature.
