A solar power purchase agreement (PPA) is a financial agreement where a developer arranges for the design, permitting, financing and installation . A Solar Power Purchase Agreement (SPPA) is a financial arrangement in which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider . The Great Plains Institute (GPI) has developed a resource guide to help local government staf and officials create community benefits agreements (CBAs) for proposed solar projects. <sup>1</sup> Under an EPC Contract, a Contractor is obliged to deliver a complete facility to the Project Company.
