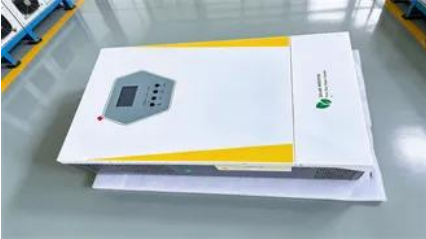
BMS Wiring Diagram
