enables grid-connected operation in solar energy systems. These inverters convert electricity from solar panels into AC and transfer it to the grid.

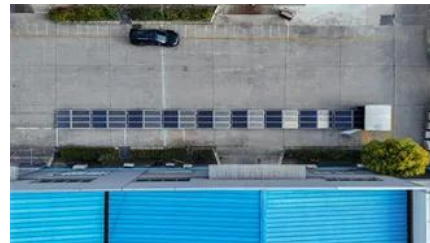
