

# What is the export tariff for Basseterre energy storage power supply



## Overview

It has a set tariff rate of 14. 25% from February 7, 2024, to February 6, 2025, and 14% from February 7, 2025, to February 6, 2026, ahead of the scheduled tariff expiration date of February 7, 2026. Exempt countries include Canada, Cambodia, Jordan, and Indonesia. The Trump administration's China tariffs have piled atop existing and developing trade barriers on battery energy storage systems, components, and materials - destabilizing the U. While existing inventories will allow project development to move forward in the short term . Looking more closely at countries with solar and energy storage manufacturing and assembly, the announced custom tariff rates are: An initial 10% tariff on all imports from China took effect on February 4, 2025, and increased to 20% as of March 4, 2025. After the 90 day pause, Chinese origin goods . Starting in February 2025, the United States introduced a range of "reciprocal" (country-specific) and sectoral tariffs. While public debate has focused on these new measures, they are only part of the story.
